- The Association represents the highest CZ domain with respect to the coordination of national and regional registrars and standardization institutes.
- In line with the approved concept of its activities, the Association supports various generally beneficial projects and projects related to the activities of the Association, providing that they are open to all potential applicants and that the projects, contributions and outputs are regularly published.

2.2 Subject of Enterprise

- The Association ensures registration of domain names of the second level, under the domain of the highest level, i.e. CZ.
- In addition, the Association operates nominal servers for the CZ domain.

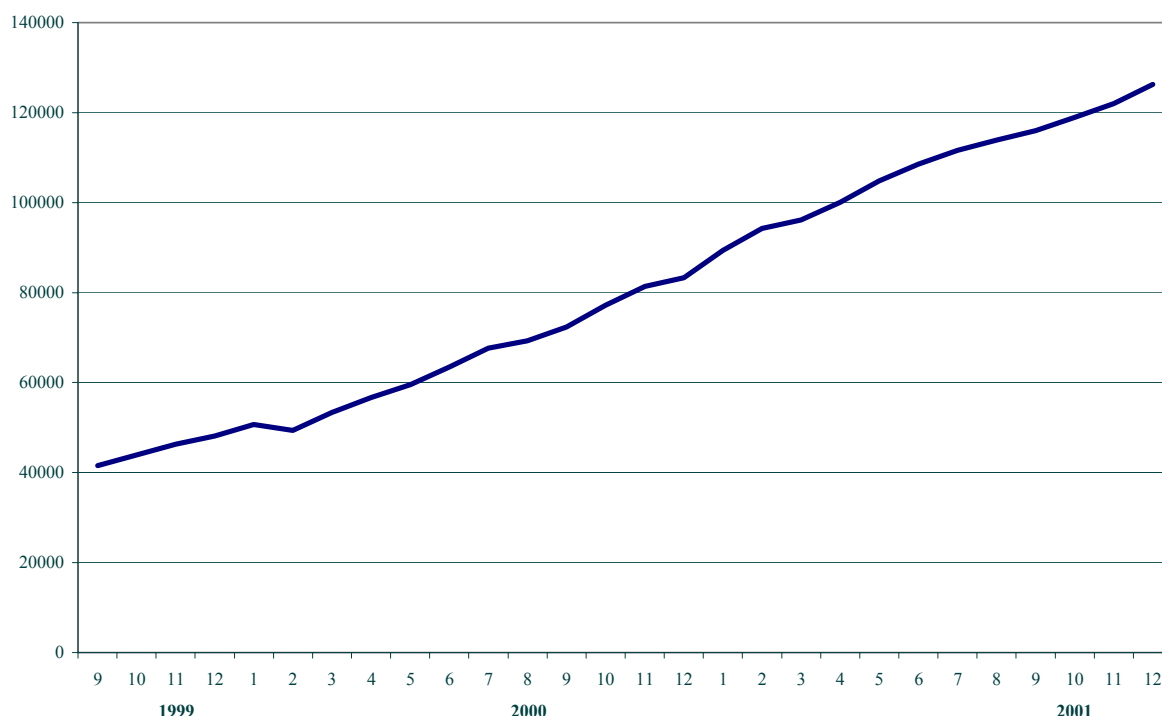

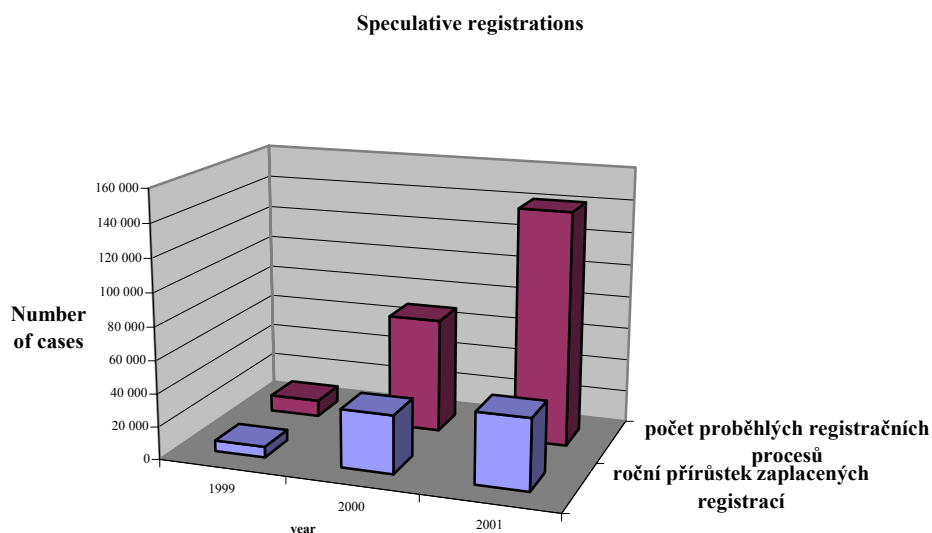
It is obvious from the data presented above that the intensity of the registration process witnessed an increasing tendency. This is particularly because of the "prospecting" activities of certain speculators who try to acquire a domain through repeatedly filed applications.

Since the ratio of the number of accepted applications to the increase in domains shows an increasing tendency, the General Assembly adopted new rules in November 2001, in order to avoid free blocking of domain names.

12. Report by Board of Directors

12.1 Statement of the Chairman of the Board

Dear Friends,

Members of the Association were entering the year 2001 rather unsatisfied with the status and services provided by CZ.NIC. The registration system had been introduced several months before and yet a number of procedures remained open and the activities pursued by the Association were exposed to a wide range of risks, against which there was no adequate protection. The Association was isolated from the general public as well as from the public administration; the mission and principles of the central TLD .CZ register were not adequately defined. Our Members were unable to come to common terms concerning further strategic policies to be pursued by the Association, and some of them were discontented with the rather poor progress in the process of creating a decentralised model of CZ.NIC with respect to our customers. Foreign experience clearly indicated the tendencies towards the "register-registrars" model, which is in many aspects much more convenient with the current needs, compared to the current model of a singular register and registrar, personified in CZ.NIC.

In response to all these tendencies, the Association's Board of Directors was reconstructed in June 2001: the new Board began to follow a new concept, processed by some active Association members and presented during the meeting of the General Assembly held in June. In addition, the Board decided to modify the Statutes and the electoral regulations in order to accommodate to the current needs and make use of the natural initiative of its active members willing to work and bear responsibility as members of the Association's supreme bodies. Furthermore, the Board concentrated on the declared but never actually realized support to generally beneficial projects related to the Internet in the Czech Republic. The Association reported considerable progress in the transformation to a decentralised model of activity, where some rough outlines of the project had been stipulated by the end of the year.

The year 2001 also witnessed our efforts to protect the good name of the CZ.NIC Association in the eyes of the general public and ensure systematic reporting of the activities pursued by the Association. In addition, the Association began to prepare measures which will eliminate possibilities for abusing some loopholes in the registration process and for unfair speculating, a situation which was often criticised by the public.

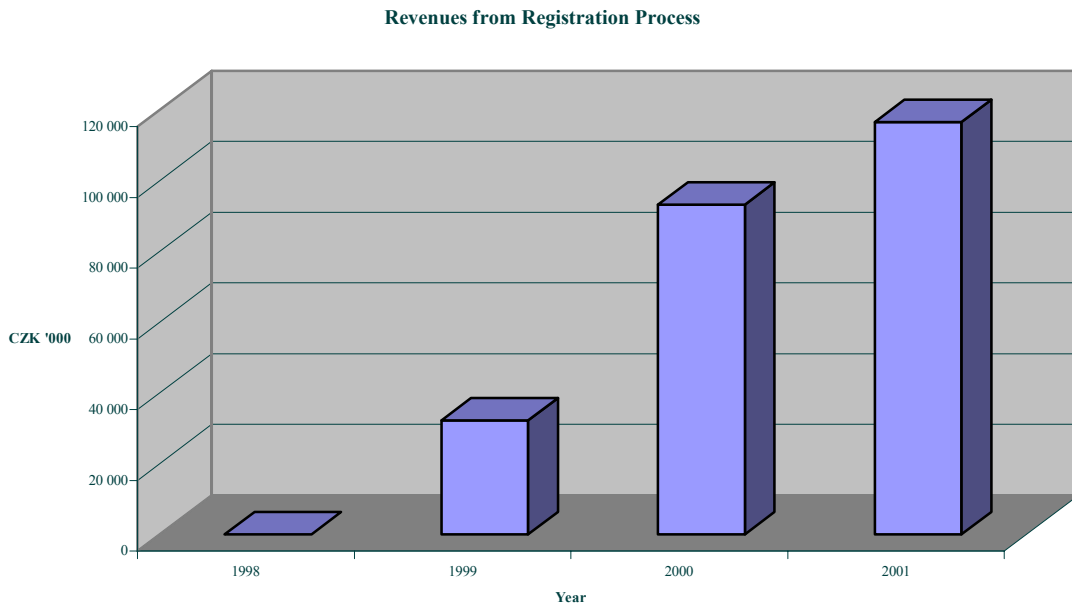
It is obvious that we could not manage to achieve all our objectives in 2001 and that there remains much to be done in the future. It is necessary to finalise our activities for fair support of generally beneficial projects, and it will be necessary to consider again the issue of solving disputes concerning domain names and find the right position for CZ.NIC, so that it would become a generally recognised authority in this area, too. It will be necessary to monitor closely and bring to a successful end the project of transforming the association to a decentralised system of registrations and many more minor but equally important issues.

I am convinced that the year 2001 was a good start towards the reconstruction of CZ.NIC and that – with the help of our employees and active members of the association – the registration of domain names of the second level will become a standard and trouble-free process which will be fully reliable for the general public.

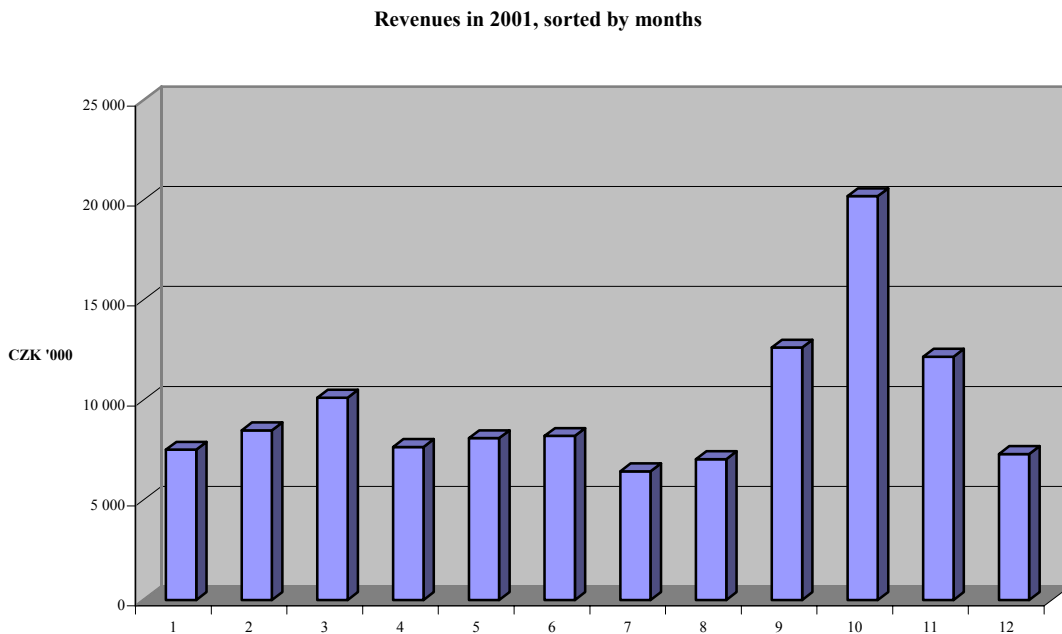

12.3 Position in the Market

There must always be only a single national domain administrator; however, there may be more than one registrar. This is why the Association – after initiating the registration process, where CZ.NIC introduced rules and acts in the role of a register and the registrar – adopted the concept of introducing more registrars into the system. This project will be the focal point of the Association's activities carried out in the second half of the year 2002 and the first half of 2003.

12.4 Strategic Objectives for the Period 2002-2005:

- CZ.NIC ensures registration and trouble-free operation of ccTLD.cz on a long-term basis
- CZ.NIC will retain the form of an association, where members are not financially involved in the trading income and where profits after tax are primarily used for financing funds, particularly those aimed at generally beneficial projects
- In cooperation with the regulatory authorities of the Czech Republic, CZ.NIC devotes its efforts to the development of rules, and their application, in order to support further expansion of the Internet in the Czech Republic. This concerns particularly the following:
 - Technical issues: transformation of the current "register – registrar" system (i.e. a single entity) to a new "register – registrars" system. CZ.NIC shall retain the function of the register.
 - Business and legal issues: intensifying the involvement of CZ.NIC in the solution of disputes, in order to become an authority for the decision-making process
- CZ.NIC shall improve its image towards the general public. In order to achieve this, it is necessary to carry out the following:
 - Adopt rules for the support of generally beneficial projects.
 - Improve communication with the public, including the release of Statutes and an abbreviated version of the Financial Statement.
 - Suppliers of services will be selected on the basis of public selection procedures (after 1 September 2003).
