Domain auctions in CZ

- Motivation
 - complains from registrants and smaller registrars
 - unequal conditions for obtaining expired domains
 - multiple analyses of domain dropcatching
 - domain fights of few domainers
 - more than 10% domains as subjects of these fights (and dropcaught within 1 day)
 - 70% domains dropcaught by 3 registrars
 - significant EPP traffic in some cases
 - registrants had to rely on domainers
 - to offer fair system for registrants
 - to be able to revise the system of free requests for registrars



Domain auctions in CZ

- How did we release domains before domain auctions
 - to April 2024
 - 60 (30+30) days of protection period
 - domain release 61st day after expiration (randomly)
 - limited free EPP requests for registrars
 - 100 requests per active domain (per month)
 - 25 000 requests as a minimum (per month)
 - price 0,1 CZK per request above limit

Domain auctions in CZ

- How do we release domains with domain auctions
 - from May 2024
 - 60 (30+30) days of protection period
 - 15 days - domains in list of domain for auctions
 - 16th day - first round of domains auctions
 - domain release after unsuccessful auctions (randomly)
 - the term depends on auction result
 - limited free EPP requests for registrars (same as before)

Domain auctions in CZ

- How does it work
 - object of the auction is the **priority right** to register the domain
 - new behavior after deletion of domain
 - not available for dropcatching
 - published in the list of domains for auctions for 15 days
 - Website: aukce.nic.cz, Domain browser - <https://www.domenovyprohlizec.cz/>
 - contains all deleted domains (no matter for what reason the domain was deleted)
 - “enlisted to an auction” in WHOIS, RDAP, EPP
 - auction doesn’t take place if CZ.NIC receives a court decision which prohibits it via preliminary measure
 - no request like it up to day

Domain auctions in CZ

- How does it work
 - 16th day after domain cancellation → English auction
 - duration 9 hours 12:00 – 21:00 (automatic extension in case of bids at the end)
 - starting price 100 Kč ~ 4 EUR
 - minimal bid steps according to current winning price
 - 3 types of bidding (hidden maximal price with automatic bids / direct bid / pre-auction bid)
 - the auction takes place in the Domain Browser (<https://www.domenovyprohlizec.cz/>)
 - only for verified bidders:
 - a natural person with a MojelD contact which is verified for electronic identification purposes
 - a natural person holding an electronic identity of another Member State of the European Union (eIDAS)
 - a legal entity with a MojelD contact that is validated in accordance with the MojelD rules
 - hiding the identity for public

Domain auctions in CZ

- How does it work
 - measures against fraud bidders
 - each identity only 1x
 - limits for 1 identity (50 active auctions, 100 tracked auctions)
 - blocking bidders who
 - doesn't pay the priority right to domain registration (penalty)
 - floods the system with DoS type requests
 - penalty = unpaid price (but at least CZK 1,000 ~ 40 EUR)
 - repeating the auction (5-round system) if occurs:
 - the priority right to domain registration not paid
 - the priority right to domain registration not executed

Domain auctions in CZ

- How does it work
 - registration of the domain from auction
 - winner
 - pays for the priority right to domain registration - 7 days
 - registers the domain by the registrar (using the holder handle from MojelID) - period of 7 days
 - the registrar sends a standard EPP command
 - registration takes place if the winner handle is listed as the holder
 - release of the domain for dropcatching after an unsuccessful auction
 - no bid in the auction, too many unsuccessful auction rounds
 - at a random moment on following day

Domain auctions in CZ

- What tools do we use?

- system for registry **FRED**
 - internally developed (open source registry system)
 - minor changes in EPP, WHOIS, RDAP
 - auctioning is operated by an auction system module (with auction API)
 - auction tools added to already existing tool Domain browser (<https://www.domenovyprohlizec.cz>)
- system of electronic identity **MojelID**
 - recognized electronic identity in the Czech republic and EU
- results of EU project RegeID (eIDAS)
 - support for EU eID in Domain browser
- Advanced DNS Analytics and Measurements (ADAM)





Domain auctions in CZ

- Results after 1 year
 - 165 000+ domains in auctions
 - 5 400+ domains auctioned (3,3% from “in auctions”)
 - 5 300+ domains with paid the priority right to domains registration (98% from “auctioned”)
 - 4 900+ domains registered (93% from “paid”)
 - 1500+ different bidders
 - 97% from Czechia (other countries: Estonia, Latvia, Slovakia, Germany, Bulgaria, Poland, Sweden, UK)
 - 80% natural persons / 20% legal entities
 - 54 bidders blocked (28 unblocked - paid penalty)
 - supported by 16 from 48 registrars (with market share 90%)

Domain auctions in CZ


- Results after 1 year
 - 1 100+ different winners
 - 65% winners won 1 domain, 28% won 2 domains, 16% won 3-5 domains
 - 10 winners won 35% auctions
 - 54% auctions ended later than at 9 pm





for 1 domain from 1 registrar



per month



per month




Count of re-registered domains

within 1 month from release




Domain auctions in CZ

- Results after 1 year
 - slight increase of renewal rate
 - too short period to be sure (auctions or because of price increase from 1st of March 25)



Domain auctions in CZ

- Results after 1 year
 - growth of total number of domains
 - other reason is because of price increase from 1st of March 25



Domain auctions in CZ


- Results after 1 year
 - 6 mil. CZK income
 - the most expensive auctions:
 - virtualnisidlo.cz - 152 077 CZK ~ 6 000 EUR
 - wzg.cz - 121 000 CZK ~ 4 800 EUR
 - zuno.cz - 119 888 CZK ~ 4 700 EUR
 - ergo.cz - 113 000 CZK ~ 4 500 EUR
 - mypage.cz - 101 000 CZK ~ 4 000 EUR
 - legal.cz - 100 000 CZK ~ 4 000 EUR

Domain auctions in CZ

- Results after 1 year

Auction price - the most common price

Domain auctions in CZ

- Delivered changes after launch
 - optimization of payment/invoice processing
 - adding “direct bid” and “pre-auction bid” besides “hidden maximal price”
 - list of domains in JSON format
 - forcing 2FA in Domain browser
 - more intelligent sorting of domains in lists (usability in CZ, SK, EN languages)
 - clearer view of bid history (available even for non-bidders)
 - public statistics (<https://stats.nic.cz/dashboard/cs/auctions.html>)
 - automatic surveys among participants

Domain auctions in CZ

- Planned and considered changes
 - better support for occasional bidders
 - watching of existing domains if these appear in auctions
 - using AI for suggesting domains in auctions
 - supporting auctions as a parameter of certification program for registrars
 - using AI for sorting and advertising domains in auctions
 - Domain browser with an auction extension as available module of FRED (open source)

Domain auctions in CZ

- Summary of main achieved goals
 - 1) The market with domains released from the registry opened to public
 - hundreds of auction participants
 - significant decline of fast domain resale
 - transparent pricing of domains by the market
 - 2) Dropcatching weakened
 - 3) Significant EPP traffic decline
 - EPP limit for registrars increased 4x (from 09/25)
 - 4) No negative impact to the domain market
 - 5) FRED as innovative SW for domain registries
 - 6) Financial income
 - ROI less than 3 years
